The work of putting on our Book Sale can be strenuous though.

Boxes of books can be very heavy especially if you must lift a lot.

Susan Wishkoski is the main chair of the Book Sale along with Sharon Barker who has offered to be available the week of the Sale with trucks, pickup, Kiwanis, etc.

At a special Leadership Meeting in December, Susan conducted a pros and cons exercise. Some of the comments discussed were:

- 1. Find a way to move books only once.
- 2. Find another storage space, where some of the sale could take place in advance.
- 3. Need to have fewer books to deal with at and after the sale.

AGAIN IN THIS ISSUE YOUR EDITOR WILL QUOTE SUSAN AS A REVIEW OF THE PARTICULARS OF HER PLAN.

"Two concerns emerged from that December Book Sale meeting: We are no longer able to lift heavy books; Too many books we receive are not saleable. I recommend that we only accept books two days ahead of the sale. The books would be delivered to the church and would save on the labor of collecting and then having to move them from other locations. We can check in the donations at the church and turn back those that are not saleable. We could organize some sort of pick-up service at this time. Finally, I recommend that we only sort books into 4 large categories-fiction, non-fiction, children's and special books of unique value. Let our customers browse. They will enjoy the treasure hunt and may buy more. One other change-on Saturday, the 8^{th} , vendors will be allowed in at 7:30 a.m. And the

sale will open to the public at 8: AM. We will not be using shelves this year. We will be displaying books in cardboard boxes. Please save your boxes.

MEMBER VOLUNTEERS ARE NEEDED:

To donate books themselves.

To set up on Tuesday.

To receive books on Wednesday and Thursday and Friday.

To run the sale on Saturday.

To help clean-up on Saturday afternoon.

To donate baked goods-cookies, muffins, etc. for the day of the sale as we are planning to serve coffee, hot tea, with the baked goods."
